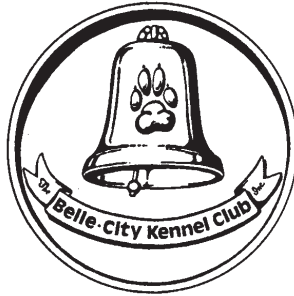

## Notice to Exhibitors

THE TRIAL SITE will be available at 7:00 am. Judging will start at 9:00 am.

The building will be available for set up on Friday, Oct 28 from 4:00 pm - 6:30 pm.

CRATING in designated areas only. CRATE SPACE IS LIMITED. X-pens will not be allowed in the building. Dogs must be removed from the Trial site immediately following the conclusion of the judging on Sunday, Oct 30. There will be no space for un-entered dogs.

No RV or Overnight parking allowed at the Trial Site.

Belle-City Kennel Club, Inc. and its members assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children.

Since bitches in season are not allowed to compete in AKC Obedience or Rally Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a veterinarian of such a claim for refund by letter hand-delivered, emailed, or postmarked before the trial commences.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. Owners or agents alone are responsible for the presence of their dogs in the ring at their scheduled time. Judges will adhere as closely as possible to the judging schedule.

ALL DOGS PRESENT MUST BE HELD ON LEASH BY THE HANDLER OR CONFINED TO THEIR CRATES except when being judged.

Dogs may not be on Flex-Leads or long leads while in the building.

EXHIBITORS SHOULD FOLLOW THEIR VETERINARIANS' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

### Transfers

Transfers will be allowed according to AKC Regulations, provided that the written request is received at least 30 minutes prior to the start of the trial.

**Dogs may not be left unattended in rooms.**

All exhibitors must be responsible for cleaning up after their dogs on the motel and trial grounds. Motels require that dogs be crated when unattended. Any damages to motels or the trial site can result in disciplinary action by the Trial Committee. It is expected that exhibitors will clean up immediately after their own dogs and strongly encourage others to do the same.

All owners/exhibitors should be aware that the entire motel grounds are considered within the trial grounds. You will be responsible for all damage to your room and may be subject to disciplinary action in accordance with the rules of the AKC. Any abuse of the grounds will be brought to the attention of the trial-giving club and its Trial Committee. Any exhibitor's entries may be refused for previous misuse of the motel facilities. This is an AKC supported measure.
